Over thirty years' experience in developing and managing complex analyses of market power, antitrust, and competition issues in regulated and unregulated industries. Areas of major strength include development of competition analyses of market-based rates in the natural gas pipeline, natural gas storage, and crude oil pipeline industries; merger analyses in regulated and unregulated industries; exclusive dealing arrangements, nonprice payments; development of litigation strategy and expert economic testimony; management of an interdisciplinary staff, and recruitment.

#### Author of two books:

The first book concluded that the market for U.S. harvested tuna was competitive despite a market structure that appeared to be dominated by only three buyers of tuna (i.e., possible "monopsony" market power).

The second book estimated the potential effect of entry on the level of competition in the relevant geographic markets for delivered natural gas under the assumption that price and entry regulation is removed.






